- (2) I hereby postpone any and all present and future entitlement I have or may have to an interest in the Property in favour of the interest of the Mortgagee to be created by the Mortgage, to the extent necessary to allow the Mortgage and any renewal thereof to constitute a valid and subsisting mortgage charge over the fee simple of the Property.
- (3) I hereby grant to the Mortgagee priority over any interest I now have in the Property pursuant to the *Family Law Act* with the intention that my interest shall be subject to the rights of the Mortgagee under the Mortgage as though the Mortgage had been created, executed, issued, delivered, advanced, and registered in point of time before my interest or entitlement arose.
- (4) I agree to execute and deliver to the Mortgagee upon request any further documents, deeds, or assurances that may be required to give effect to my covenants contained in this Agreement.
- (5) I agree that if any portion of this Agreement is found to be void, voidable, or unenforceable, the balance of this Agreement shall remain enforceable.
