(4)	I agree to execute and deliver to the Mortgagee upon request any further documents, deeds, or assurances that may be required to give effect to my covenants contained in this Agreement.
(5)	I agree that if any portion of this Agreement is found to be void, voidable, or unenforceable, the balance of this Agreement shall remain enforceable.
